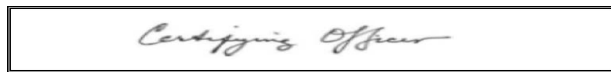

2. **Inform us as soon as the Notice of Filing is posted** so we may proceed with the preparation of the H-1B petition.

After the LCA has been posted for ten (10) consecutive business days:

1. Remove the posted Notice of Filing(s);
2. Complete the Acknowledgement of Posting portion of the notice, which includes: the date posted, the date removed, and location (address) of the worksite where posted, and have the representative who posted the LCA sign the Acknowledgement of Posting; and
3. Place a copy of the signed notice of filing and draft LCA in your Public Access file (or binder).
