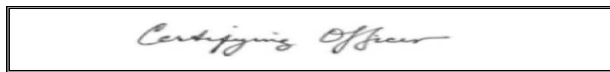

3. Place a copy of the signed notice of filing and draft LCA in your Public Access file (or binder).
